INSTRUCTION

Distribution of Enrolment and Graduates

The Manila Campus (Main Campus) received a total of 14,422 enrollees while EARIST Cavite Campus (ECC) received a total of 3,701 enrollees.

The Academic Council of the Institute approved the first virtual 53rd Commencement Exercises of December 28, 2020 with the theme "Sustaining Quality Graduates Responsive to Industry 4.0" headed by two Magna Cum Laude.

The Graduate Program (Manila and Cavite Campuses) had 117 graduates.

The Undergraduate Program (Manila Campus) had 2,091 graduates.

In the Graduate Program for EARIST Cavite Campus, ten (10) graduates received their doctoral degrees while nineteen (19) were conferred their master's degrees.




The pie graph representing the graduates in the doctoral and master's degree program.



The image above shows the distribution of graduates in the Undergraduate Program.



A graph representing the graduates in the College of Business Administration's course programs.



> A graph representing the graduates in the College o fIndustrial Technolog y's course programs.




Enrollment

Manila Campus (Main)

The indomitable aggression of the COVID19 pandemic did not cease the school to deliver its services and mandate to its clientele.



For the First Semester SY 2019-2020, a total of 774 were enrolled in the Graduate Program or 5.37% for the Main Campus and 4.27% for the two campuses (Main and Cavite) in the whole total population of the Institute.




In the Undergraduate Program, a total of 13,648 were enrolled which comprised the 94.63% for the Main Campus and 75.31% for the two campuses (Main and Cavite) in the whole population of the Institute.




Virtual Orientation Program


"AYUDA" by Jemson Conje was a finalist in the 53rd Shell National Students Art Competition in 2020.


17th Estilo de Vida



Pure and Applied Sciences Education and Social Sciences Business, Psychology, and Public Governance Technology and Innovation


The colloquium continues to attract participants in the institute as awards and prizes are also given to outstanding researches and presenters alike.


The distribution of relief goods to the Typhoons Rolly and Ulysses affected areas.








The Certificate of Compliance presented to EARIST by the Freedom of Information.




International Education Summit and Awards 2020




Conduct of Activities















DESIGN AND CONSTRUCTION OF THREE-STOREY MULTI-PURPOSED BUILDING

Part of the EARIST Infrastructure Development Masterplan Plan, envisioned by the EARIST President, Dr. Editha V. Pillo, through the EARIST Institutional Infrastructure Planning and Development Office (EARIST-IIPDO), is the provision of a way for PWD and the elderly to easily access all floors of the buildings of EARIST and ways to exit the same, from any floor, during emergency. Combined with centralized ramp system of the new multi-level Computer Laboratory, and the provision of elevators at strategic locations in school compound, this three-storey connecting building was designed to provide easy access from the main building to and from the CEAFA building, up to the fourth level. Now, students and teachers can easily access to and from both buildings without going down, reducing stress and travel time when moving from one class or office to another. The unique idea of this structure serving as both bridge and functional offices was conceptualized by the EARIST Campus Architect Maundelito Florendo, and was voluntarily studied by then student and now EARIST alumnus, Mr. Jonathan Torzar, through his architectural thesis.






REPAIR/REHABILITATION OF ROOFING AND GUTTER OF THE ADMINISTRATIVE BUILDING AND ADJOINING SPACES





EARIST Advisories

As an academic response to the onslaught of COVID19 pandemic, the administration issued advisories concerning students, employees, and faculty members of the Institute as follows:

Advisory No. 01, s.2020

Suspension of Classes and Academic Processes March 18, 2020

The advisory suspended all classes and all academic processes, including alternative learning modules (online/Google classes) within the duration of the Enhanced Community quarantine (ECQ) from March 17 to April 14, 2020.

Advisory No. 02, s.2020

Preparedness and Contingency Plan for Coronavirus Pandemic March 19, 2020

The aggressive escalation of the coronavirus prompted the administration of this Institute to issue this advisory where specific guidelines were indicated as precautionary measure to avoid the spread of the dreaded virus and may be utilized as a response management after the pandemic.

Advisory No. 03, s.2020

Plans after the Lifting of ECQ on May 15, 2020 May 5, 2020

This advisory was the proposed intervention of the Institute in relation to the academic requirements of students, graduation, admission, and the flexible learning system and other possible modes of delivery in place of the in-campus learning that it can adopt during the First Semester of Academic Year 2020-2021, in accordance with Inter-Agency Task Force (IATF) Resolution No. 29, series of 2020.

Advisory No. 04, s.2020

Guidelines during the Modified ECQ from May 16-31, 2020 May 14, 2020

This advisory stated that only skeletal Work Force shall be allowed to report on-call basis to render necessary services (transportation service is being provided to employees). The rest non-teaching personnel and faculty who render 40 hours shall be under work-from-home (wfh) scheme.

Advisory No. 05, s.2020

Guidelines on Alternative Work Arrangements during the General Community Quarantine (GCQ)

May 28, 2020

The Institute issued the Guidelines on Alternative Work Arrangements (AWA) during the General Community Quarantine (GCQ) based on the guidelines in the Civil Service Commission (CSC) Memorandum Circular No. 10, s. 2020 which reads "Revised Interim Guidelines for Alternative Work Arrangements and Support Mechanisms for Workers in the Government during the Period of National Emergency due to COVID19 Pandemic", CHED COVID Advisory No. 7, and IATF Resolution No. 38 and No. 40.

Advisory No. 06, s.2020

Guidelines for the Regular Faculty Members and Part-Timers/ Guest Lecturers for both Undergraduate and Graduate Programs during the Extension of Second Semester, SY 2019-2020

June 1, 2020

This advisory gave instruction that the Second Semester was extended until June 22, 2020 to give time for the students and faculty members to complete the academic requirements.

Advisory No. 07, s.2020

Guidelines on Prevention and Control of Covid-19 Pandemic in the EARIST Workplace and Employees

July 2, 2020

This guidelines aimed to set standard on health protocols for EARIST to become a COVID-19 free Campus; to maintain a safe workplace; and to safeguard the employees in light of the SARS COV 2 pandemic. Corresponding, the institute intensified its campaign to prevent and control the spread of the dreaded virus among its employees to ensure their health and well-being as members of the workforce



Guidelines on Alternative Work Arrangements for Academic Personnel during the Month of August 2020 July 20, 2020

The EARIST Administration issued this advisory giving instructions to academic personnel on their alternative work arrangements, that was deemed necessary in this time of COVID 19 pandemic aggression

Advisory No. 09, s.2020

Guidelines during the Modified Enhanced Community Quarantine (MECQ) from August 4-18, 2020 August 3, 2020

The modified Enhanced Community Quarantine (MECQ) implementation prompted the EARIST Administration to issue this advisory where only the Authorizes Persons outside Residence (APOR) were allowed to go out since public transportation was suspended and only critical government service activities were allowed



Alternative Work Arrangements during the General Community Quarantine (GCQ)

August 18, 2020

The school administration issued this advisory which gave instructions to the school's workforce during the General Community Quarantine (GCQ) being implemented by the national government to ensure that the functions and mandate of the school personnel will not be risked while they are performing their tasks.

It can be noted that the academic personnel rendering 30 hours and who were below 21 years old and those above 60 years old were placed under the Work-From-Home Arrangement. While those who were rendering 40 hours and 21 years old and not over 60 years old were required to report for physical reporting on a 4-day working schedule.



Extension of the Opening of Classes for the First Semester School Year 2020-2021

September 4, 2020

The re-imposition of the Modified Enhanced Community Quarantine prompted the school administration to issue this advisory regarding the extension of the opening of classes for the First Semester, School Year 2020-2021. Instead of September 7, 2020, the opening of classes was moved to October 5, 2020. Additionally, this advisory also revised the school calendar as endorsed by the EARIST Administrative Council.

Advisory No. 12, s.2020

Work Guidelines during the Regular Classes Starting on October 5, 2020

October 2, 2020

This advisory was issued by the administration to facilitate learning during this time of pandemic. The adoption of flexible learning in order to deliver its mandate to its clientele was included herein like the modalities of asynchronous and synchronous teaching through online.



Five-Day Academic Break (Suspension of Synchronous and Asynchronous Classes) November 16, 2020

After two typhoons (Typhoon Rolly and Typhoon Ulysses) wreaked havoc in the Philippines, many places were declared under calamity by the government. To ease the burden of the victims and help them recover from the devastation, a five-day academic break or suspension of synchronous and asynchronous classes) was implemented by the Institute. This advisory prompted the employees, faculty members, and students to recuperate from the destruction caused by the two typhoons.


EARIST Cavite Campus

The recipients of the food packages were delighted with the humanitarian token from the EARIST Cavite Campus administration.









Tree Planting
