2.0 The Review and Compliance Committee shall:


- 1) Authorize the Chief Administrative Officer and/or those in acting capacity in every department, office and bureau to receive and evaluate the accomplished SALN of their respective offices; and
- 2) Submit a final report to the President on or before June 30 of every year, copy furnished the Office of the Deputy Ombudsman.

3.0 The HRMS shall:

- 1) Evaluate as to whether the SALN was submitted on time by the employee/personnel, with complete data, using the proper form;

- 2) Receive the SALN on or before May 30 of every year, classified as:
 - a. Employees who filed their SALNs with complete data;
 - b. Employees who filed their SALNs but with incomplete data; and
 - c. Employees who did not file their SALNs.
- 3) Prepare the SALNs (soft and hard copies) of the Institute, and consolidate the same, copy furnished the Office of the Deputy Ombudsman on or before June 30 of every year; and
- 4) Prepare Transmittal Letter to the Office of the Deputy Ombudsman for the SALNs of the Institute.

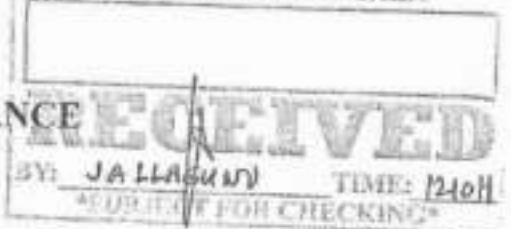
